
Dear Robin Rohwer,

Please have a check sent to me for the missing \$108.30 that was reported on my Federal Form W-2's over what was reported on my Earnings Statements for the years 2007 and 2008. It is either that or send me corrected W-2's. Do not include it in this year's pay as it would still be reported income that I did not receive. Should it really matter for only \$54? Of course it matters. Here is the latest info that crimes of TAX FRAUD have been committed by Swift Transportation. I, Daniel Mahnke, have just discovered on 3/1/09 that Swift Transportation has reported an extra \$54.15 of earnings on each of my Federal Form W-2's over the amount posted on my Earnings Statements for the years 2007 and 2008. Additional Subtitle C taxes were withheld as well. The CASDI was the same in 2007 on both documents. There was no difference for the year 2006. It doesn't matter if I'm the only employee that you did this to. Swift Transportation committed TAX FRAUD any ways if this was not just a clerical error, but if you did it to approximately all 22,000 employees, or how many you have, it would be \$1,188,000 that you reported as expenses for which you did not have to pay taxes on. I couldn't have committed the TAX FRAUD here for these years as I have no control on what info you place on my documents. Swift Transportation has garnished my wages because you believe I must pay them, but for you to cook the books to report more expenses than what you actually have is a crime.
